2103.02 Disclosure of Interests

2103.03 Minutes of the Meeting Held on 8th February 2021

2103.04 Chair's Formal Announcements

The Chair confirmed that a National Census is to take place on 21st March 2021 and the Police, Fire and Crime Commissioner Election on 6th May 2021.

2103.05 Finance

2103.06 Notice-Board and Grant Funding

The new noticeboard having been delivered **it was resolved that** work to refurbish the old board should commence as soon as practicable, dependent on the weather.

2103.07 Resilience Plan

It was noted that the receipt of maps and some data protection consents is awaited and **it was resolved that** this item therefore be relisted on the agenda for the next meeting.

2103.08 Salt Spreader

It was resolved that the proposal to purchase a salt spreader be reconsidered by the PC in September 2021.

2103.09 Risk Assessments and Inspection Reports

PS reported that he had examined the concrete bench opposite the brick bus shelter and that the cost of timber to carry out the repair would be £20 approximately and further that he was arranging to examine the bench stored by SW to establish the extent of the repair required which he anticipated would be of similar cost.

PS also proposed that in due course the dog waste bin next to the gate into the Millennium Wood (MW) be moved a little way away from the gate. In the meantime, the MW remains closed and he is replacing the sign to that effect.

ES reported that the contractor has agreed to keep the strimmer away from the legs of the swing unit and benches in the Play Area and is going to spray around their bases keeping a very close perimeter to them. **It was resolved that** NS and PS should continue to monitor closely.

There is a suspicion that a planter is being overlooked in the schedule of regular inspections. It is believed that it is the wooden tub in the play area and **it was resolved that** ES should check the number and whereabouts of the planters. **It was further resolved** that ES and PS should examine the cracked and unbolted planter on Main Street opposite Wycliffe Road junction.

Receipt today of the report from the arborist was confirmed and **it was resolved that** PS would seek confirmation from North Yorkshire County Council (NYCC) as to ownership of the trees omitted.

2103.10 First Aid Training

Pursuant to minute 2102.10 ES reported that the cost of first aid training would be limited to the rental of the hall, lungs for dummies and for certification and that the training ought to be able to proceed in June. **It was resolved that** the matter be relisted for consideration by the PC once ES had obtained detailed costings.

2103.11 Police Community Report

It was confirmed that no report had been received since that discussed at the last meeting.

2103.12 Neighbourhood Watch

It was resolved that NS should gauge interest by way of an insertion in the Parish Magazine.

NYCC Highways Drainage is to investigate further.

2103.15 Parish Portal

ES reported that the PC is still encountering difficulty in securing access but is hopeful that the problems will be resolved shortly.

2103.16 Secure E mail Addresses

It was resolved that this matter be considered by the PC further at its June meeting.

2103.17 Planning

It was resolved that the PC had no observations in relation to either 21/00423/FUL (Haswell Grange) and 2100479/MRC (The Coppice, Wycliffe Road)

It was further noted that the landscape planting required by the planning consents under references 17/01123/FUL and 19/01789/FUL (Manor House Farm) has commenced.
