- a) There has been theft of heating oil (approx. 300 litres) from a domestic dwelling in Wycliffe Road. Local PCSO is aware and the resident is in the process of installing a PIR security light and CCTV
- b) Report (from Cllr Cramond) of car driving around Golden Acres during the early hours. PCSO has been informed. JS checked CCTV but was unable to find anything
- c) Recent increase in cycle thefts in the Northallerton region with some being dumped and others being set on fire

# **Planning Applications**

- a) Proposal for a 28MW solar farm on land at Frigidale Mill, Northallerton, DL6 2NE ("East Cowton Solar Farm") Cllrs received a verbal update from ES that Project Managers will provide updates as they are available and plan to attend a parish council meeting in either May or June 2024
- b) Dwellings Birkby Lane ZB24/00105/OUT. Outline application with some matters reserved (considering access) for the construction of 15 dwellings OS Field 4109 East Cowton North Yorkshire – ES provided a verbal update that at present there is no formal outcome on this application. ES advised that local flood authority comments and recommendations need clarifying as the documents submitted on the planning hub are limited. ES has enquired regards the cumulative effect of the development of 15 further dwellings and is awaiting a response
- c) Councillors to consider ZB24/00351/OUT Outline Planning Application with some matters reserved (Considering Access, Appearance, Layout and Scale) for Conversion of an existing garage to create a 2 bedroom apartment. this includes a modest extension ES invited comments from Councillors and AWr was of the opinion the aesthetics of the proposal were not pleasing and had consideration been given to including a pitched roof. The applicant being present at the meeting agreed the current drawings are not ideal but he is reluctant to submit a more aesthetically pleasing option unless outline planning permission was granted. A member of the public confirmed they would not be happy with a pitched roof as that increases the height of the elevation. Cllr Cramond enquired whether inspections for asbestos had been carries out, ES advised this would be included as part of the construction plan. ES opened the floor for questions:
  - Occupant of 12 Wycliffe Road has no concerns unless access to the driveway is impeded
  - Question regards the 1967/69 signed title agreement for Shellex Pipes, situation needs to be identified. Although the tanks are unused the companies responsible have disappeared from Companies House records so assumption ownership belongs to the Crown

Resolved the Clerk should contact the planning department to confirm Councillors have considered the proposal and at present have no comments to make.

- b) Question raised as to why new planning notices regarding the development at Bungalow farm have been posted ES advised there are no changes to proposals
- c) Issue of commercial vehicle belonging to Lowes being parked on the pavement. ES advised the PCSO has investigated but will raise it again
- d) Noted there has been a deterioration on the path to the side of Preston House
- e) Note the commemoration tree is looking untidy and needs branches removed ES advised this will be carried out
- f) Question raised as to whether enquiries could be made to find out who is managing the estate for the empty bungalow on Wycliffe Road and whether the garden can be tidied. ES stated that this was probably not possible and that access to the property is not possible as the property is under private ownership and permission would be required to enter
